- 4. The secretary will be held accountable to the Vet Incentive Program Board. The duties and responsibilities of the secretary-treasurer will be set out by the board.
- 5. The Veterinarian will be located in South East Saskatchewan, working two weeks a month for two days at a time.
- 6. Maintaining a record of receipts and payments shall be the responsibility of the R.M. of Mount Pleasant No. 2. Quarterly, the R.M. of Mount Pleasant No. 2, will invoice the Municipalities their 1/6 share of the Veterinarian expenses. Veterinarian expenses include: Mileage from Weyburn to Carnduff and living expenses while working under this agreement. If the veterinary expenses need to be adjusted, a meeting of the Board will be called to discuss.
- 7. Each Municipality will send their Committee Appointments annually to the secretary-treasurer of the Board.
- 8. Six (6) month notice must be given, in writing, to the Secretary of the Board for a Municipality to leave from the Vet Incentive Program Board.
