## BYLAW NO. 2023-09

## Relief Ambulance Housing Bylaw

A bylaw of the Town of Carnduff in the Province of Saskatchewan, to provide for entering into an agreement with the R.M. of Mount Pleasant No. 2, R.M. of Agyle No. 1, R.M. of Reciprocity No. 32, Village of Gainsborough, and Village of Carievale, which agreement allows for the expenses of a rental location used to house relief ambulance drivers.

The Council of the Town of Carnduff, in the Province of Saskatchewan, enacts as follows:

1. The Town of Carnduff enter into Agreement identified as Schedule "A", attached hereto and forming part of this Bylaw, with the

## APPENDIX "A" TO BYLAW NO. 2023-09 RELIEF AMBULANCE HOUSING AGREEMENT

This Agreement made this 15th day of May, 2023 BETWEEN:

Rural Municipality of Argyle No. 1 Rural Municipality of Mount Pleasant No. 2 Rural Municipality of Reciprocity No. 32 Town of Carnduff Village of Gainsborough Village of Carievale

THE PURPOSE OF THIS AGREEMENT SHALL BE TO SET OUT THE TERMS AND CONDITIONS OF PARTICIPATION IN THE RENTING OF THE SUITE AT 2-212 2<sup>ND</sup> STREET EAST, CARNDUFF, SASKATCHEWAN FOR THE PURPOSE OF HOUSING RELIEF AMBULANCE WORKERS.

## IT IS MUTUALLY AGREED THAT:

- 1. The unit of which will be rented, owned by the Saskatchewan Housing Authority, is located at 2-212 2<sup>nd</sup> Street West, Carnduff, Saskatchewan. The monthly rent will be \$730.00 per month, with a \$730.00 security deposit due upon establishment of the lease.
- 2. The R.M. of Mount Pleasant No. 2 will be the unit's lease-holder, will obtain the required insurances for the unit, will obtain furnishings for the unit, as well fit the unit with wireless internet.
- 3. The R.M. of Mount Pleasant No. 2 will, on a quarterly basis, invoice the participating municipalities for the 1/6 share of the unit's expenses, including security deposit, costs to furnish, rent, insurance premiums, miscellaneous cleaning and supplies, and wireless internet charges.
- 4. 6 months' notice must be given, in writing, to all municipalities in participation of this agreement if a municipality wishes to no longer participate.
