BYLAW 2023-15

A BYLAW OF THE TOWN OF CARNDUFF TO ESTABLISH, CHARGE AND COLLECT RATES FOR THE PROVISION OF WATERWORKS AND SANITARY SEWERAGE UTILITY SERVICES BY THE TOWN OF CARNDUFF.

The Council of the Town of Carnduff in the Province of Saskatchewan, pursuant to Section 23 of The Municipalities Act, enacts as follows:

Council of the Town of Carnduff, in the Province of Saskatchewan, enacts as follows:

- This bylaw shall be known and may be cited as the "Water and Sewer Rates Bylaw" of 1. the Town of Carnduff.
- The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
- Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
- Persons who dump effluent from sewage septic or holding tanks into the Town of Carnduff Wastewater Storage Pond shall pay for such services a rental rate or service charge in accordance with Schedule "C" attached.
- The charges set out in Schedule "D" attached shall be designated as capital infrastructure charges for financing the relocation and construction of a lagoon. These charges are applicable to all persons who own or occupy premises to which property is serviced with Town sewer utility services. The charges shall be applicable during temporary disconnection periods also.
- Accounts for water service and/or sewer service shall cover a period of one (1) month, and shall be rendered on or before the last day of the month next following such period. Temporary disconnections shall be charged \$50.00 for shutting off the water, and \$50.00 for turning the water back on.
- Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$100.00 to cover the expenses of turning the water on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be \$150.00.
- Bylaw 2020-10 is hereby repealed.

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Saskatchewan Municipal Board - Local Government Committee.

SCHEDULE "A"

Water Rates

1. The following billing rates shall be charged and levied against all commercial and residential consumers within the Town of Carnduff limits from the town's waterworks where a meter has been installed:

Consumption	<u>Charge</u>
0 to 2,000 Imperial Gallons	\$ 51.88 Minimum
2,001 to 7,000 Imperial Gallons	\$ 10.44 per 1,000 Imp Gallons
7,001 to 12,000 Imperial Gallons	\$ 11.83 per 1,000 Imp Gallons
12,001 to 999,999 Imperial Gallons	\$ 13.23 per 1.000 Imp Gallons

The following billing rates shall be charged and levied against all consumers outside the Town of Carnduff limits from the town's waterworks where a meter has been installed:

Consumption	<u>Charge</u>
0 to 2,000 Imperial Gallons	\$ 62.26 Minimum
2,001 to 7,000 Imperial Gallons	\$ 12.53 per 1,000 Imp Gallons
7,001 to 12,000 Imperial Gallons	\$ 14.20 per 1,000 lmp Gallons
12,001 to 999,999 Imperial Gallons	

 Water rate for water passing through a municipal line to a temporary residential or commercial un-metered service shall be:

\$51.88 per month

4. Water sold from the Town's reservoir, as general water sales shall be at the following rate:

\$0.05445 per gallon

SCHEDULE "B"

Sewer Rates

Consumers who own or occupy premises drained or required by bylaw to be drained into the Town's sewage system shall pay for such a Billing Rental or service charge based on water consumption in accordance with the following:

Consumption	Charge
0 to 2,000 Imperial Gallons	\$26.77 Minimum
2,001 to 999,999 Imperial Gallons	\$6.16 per 1,000 Imp Gallons

SCHEDULE "C"

Wastewater Storage Pond Rates

Persons who dump effluent in the Town of Carnduff Wastewater Storage Pond from a sewage septic or holding tank shall be charged a flat fee of \$100.00 for each discharge.

SCHEDULE "D"

Capital Infrastructure Charge

Consumers who own or occupy premises to which property is serviced with Town sewer utility services shall pay a rate of \$33.35 per month.

Infrastructure Rate: Residential -- \$33.35 Commercial -- \$33.35
