2020 Municipal Election Information be required to present valid identification.

Identification accepted includes:



- One photo piece of government-issued ID (Example: drivers license); OR
- Two pieces of ID, one with address. (Example: birth certificate and utility invoice)

WHO CAN VOTE?

In order to vote in a municipal election you must:

- be a Canadian citizen;
- be at least 18 years of age;
- have resided in Saskatchewan for at least six consecutive months immediately



preceding the day of the election; and

- have resided in the municipality, or on land now in the municipality, for at least three consecutive months immediately preceding the day of the election; OR
- is the owner of assessable land situated in the municipality, or land now situated in the municipality, for at least three consecutive months immediately preceding the day of the election.

WHAT DO I NEED TO BRING TO VOTE?

When you attend the polling station to vote, ALL VOTERS will



COVID-19 MEASURES & WHAT TO EXPECT

- When arriving at the Municipal Services Building to vote, you will enter the Town Office through the east door of foyer. In order to ensure one way traffic you will be asked to leave using



the back door once you have voted.

- Upon entering we ask you hand sanitize and follow physical distancing markings on the floor.
- Elections staff will be cleaning door handles, pens, chairs and poll booths after each use. Elections staff will also be masked.
- We encourage voters to wear masks when attending to vote.

Utility Billing CHANGES! New Billing Cycle

Exciting news! Effective January 2021 we will be moving to monthly water and sewer utility billings. The Town has been granted our approval for this change from the Saskatchewan Municipal Board.

Beginning in the New Year we will start processing our utility bills at the

end of each month. This means you will receive your bill the start of the



following month. For example, on January 31st we will read the meters and then process the invoices. You will receive your bill via email or mail sometime the beginning of February. The bill you receive will be your utility bill for consumption for the full month of January.

BENEFITS OF MONTHLY BILLING

Why change to monthly billing?

Council discussed at length whether to make the change to monthly billing or continue with quarterly billing.

The main benefits to monthly billing which attributed to the decision to make the change include:

- Ouicker leak detection.
- A smaller monthly cost does not seem as intimidating to pay as a larger quarterly cost.

- Monthly bills will make budgeting easier for those who struggle to budget or manage expenses.
- The water and sewer utility bill will now be more consistent with other utility bills



such as power, energy and phone.

- Misplaced or unpaid bills will now be caught quicker.
- Allow for increased communication with our residents through a monthly newsletter vs a quarterly newsletter.

HOW WILL THE TRANSITION WORK

In order to transition to monthly billing we will be processing a utility bill the end of December. Any properties whom have consumed more than 6000 gallons since the October billing will receive a bill for that overage only. Expect to receive



the bill the first week in January. If you have NOT used more than 6000 gallons since the October

billing you will NOT receive a bill.

OPTIONS FOR RECEIVING & PAYING YOUR BILL
