BYLAW 429-12

A BYLAW OF THE TOWN OF CARNDUFF TO FIX RATES AND GRANT ACCESS OF RAW WATER

The Council of the Town of Carnduff in the Province of Saskatchewan, pursuant to Section 8 of *The Municipalities Act*, enacts as follows:

- 1. This Bylaw shall be known and may be cited as the "Raw Water Access Bylaw" of the Town of Carnduff.
- 2. Any company and/or individual may apply for the right to access raw water from the Town by completing a written application. The written application shall be Form "A", attached hereto and forming a part of this bylaw.
- 3. It is further agreed and acknowledged that all raw water obtained from this well is nonpotable.
- 4. The Town of Carnduff shall charge an annual fee for each accepted applicant in the amount as indicated in Section 5.
 - a) The applicant will not be permitted access until the annual fee has been received.
 - b) Subsequent annual fees shall be invoiced in January of each year.
 - c) All annual fees must be paid regardless of the amount of access required throughout the year.
- 5. The annual access fee shall be:

 - a) \$200.00 if application is received between January 1st and January 31st.
 b) \$183.00 if application is received between February 1st and February 29th.
 - c) \$167.00 if application is received between March 1st and March 31st
 - d) \$150.00 if application is received between April 1st and April 30th.

 - e) \$133.00 if application is received between May 1st and May 31st.
 f) \$117.00 if application is received between June 1st and June 30th.
 g) \$100.00 if application is received between July 1st and July 31st.

 - h) \$83.00 if application is received between August 1st and August 31st.
 - i) \$67.00 if application is received between September 1st and September 30th.
 j) \$50.00 if application is received between October 1st and October 31st.

 - k) \$33.00 if application is received between November 1st and November 30th.
 - 1) \$17.00 if application is received between December 1st and December 31st.
- 6. If the Town Administrator does not accept the application, the applicant may appeal to the council of the Town at any regular meeting.
 - a) The applicant must provide notice of the appeal in writing two weeks prior to the meeting at which the applicant wishes his appeal heard.
 - b) The Council may adjourn any such appeal to any subsequent meeting from time to time.
 - c) The decision of the Council is final.
- 7. The account access shall be non-transferable; and only grants access to that company and/or individual.
- 8. The Town Administration Office shall prepare billings on a monthly basis.
 - a) The monthly bills shall show all rates and charges owing to the Town and mail such billings to the company and/or individual.
 - b) Total amount shown as owing on the billings is due and payable on the date of mailing to the company and/or individual.
 - c) Any amounts that are and remain unpaid after 20 days from the date of billing shall be charged 10% interest and added to forming a charge owing and payable in the same manner as set out in the subsequent clauses of this bylaw.
 - d) Access may not be permitted, subject to written notification, at any time.
- 9. The charges to be paid shall be as follows: Yearly fee as outlined in Section 5 and 0.0066 cents per liter for access to the raw water.

- 10. If the company and/or individual no longer require access to the raw water, they are required to notify the administration office in the form of a written letter.
- 11. If any section, sub-section, clause, sentence, phrase, or other portion of this Bylaw is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, that portion shall be deemed a separate, distinct and independent provision and the holding of the court shall not affect the validity of the remaining portions of this Bylaw.
